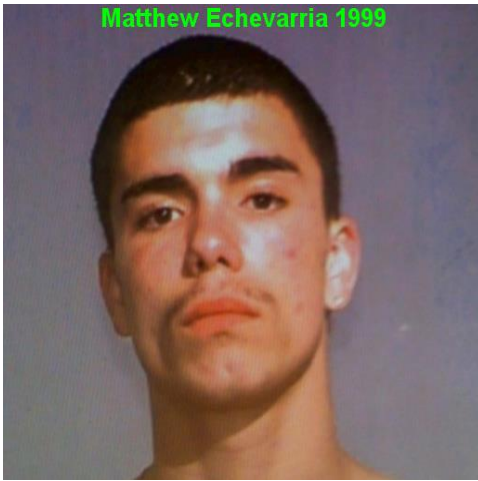


I Was WRONGFULLY CONVICTED of a Murder I DID NOT Commit

**HELP ME PLEASE
I AM INNOCENT**



My name is Matthew Echevarria I was wrongfully convicted, sentenced to 50 years, and incarcerated for a murder I DID NOT commit.

On June 20, 1999, at 3:18 AM, a 20 year old white male Robert Mirabella of Elmwood Park was fatally shot at 7109 W. Grand Chicago. The shooter was described to police by **TWO eyewitnesses** at the scene as having a **"GREEN-WINGED DRAGON TATTOO"** on his left shoulder. **I do not have a dragon tattoo.** This can be verified at the Illinois Department of Corrections website.

The suspects involved were described as male Hispanics. There were 4-5 perpetrators, Witnesses stated that these perpetrators came out of Nick's Grill, a Mexican restaurant, located on the 7000 block of West Grand Ave. The perpetrators had an altercation with the victim Robert and his group of friends. One of the suspects fatally shot Robert in the chest. 40 days later on July 30, 1999 The Police asked my mother to have me go to the 25th district police station for questioning. I did so on my own accord to find out what they wanted. The result was being denied a request for an attorney or a phone call, subjected to repeated interrogations, and deprived of sleep for the next 48 hours, 20 of those hours I was handcuffed to the wall sitting on a metal bench. I was identified in a questionable lineup by **Roberts friends, who were shown photos of me as "the shooter" by detectives on more than one occasion before the lineup**, charged with, and subsequently found guilty of first degree murder, and sentenced to 50 years in prison.

I also became a victim of the this tragedy and miscarriage of justice.

I have proclaimed my innocence from day one.
